	EPBC Approval Annual Compliance Report	 The EPBC 2020 Annual Compliance Report has been prepared and submitted in March 2021. The report is available on the Stratford Coal website.
Regulator	MOP & Rehabilitation Management Plan	 A new Stratford Mining Operations & Rehabilitation Management Plan was lodged with the Resources Regulator in January 2021. The MOP reflects the proposed mining and rehabilitation activities for the next 3 years. The MOP has been provided to CCC Members for consultation. The Resources Regulator has requested additional information in the MOP. SCPL is currently preparing for resubmission.




3a. Air Quality Management


Management Area	Project	Status
Air quality monitoring	Real-time air quality monitoring	 The real-time air quality TEOM monitors in Stratford and Craven villages continue to operate. General ambient PM10 dust levels have been very low throughout Summer/Autumn due to consistent rainfall. The real-time air quality management system analyses monitoring data from the TEOM units and records times when the air quality criteria is likely to be exceeded. The system will then provide alarms to staff to implement additional dust mitigation measures where required. No triggers have been received relating to mining operations.

- Generally good overall air quality.
- All sites below DPIE limit. Air quality results lower during months with higher rainfall.
- Steep decreasing trend during December 2020 due to elimination of bushfire affected results in 2019.
- HVAS results provide more reliable data compared to dust deposition results and should be referred to when interpreting dust emissions.

For the annual reporting period no blasts have exceed 5mm/s. No blasts recorded fume during the quarter.



Monitoring	Monthly Noise Survey	 Monthly attended noise monitoring was undertaken during Q1 2021. No non-compliant results were recorded during the surveys. Reports will be made available on the Stratford Coal website. The next monitoring is scheduled in June 2021.
Real-Time Noise	 Real-Time Noise System Additional Real-Time Noise Monitors Noise forecast reports. 	 Real-time noise monitors continue to operate near Stratford village and Craven Village. The integrated real-time noise management system is operational. The system analyses monitoring data from the noise units, the weather station and the inversion towers and records times when either the noise criteria is likely to be exceeded or when noise enhancing weather conditions are present. The system will then provide alarms to staff to implement additional noise mitigation measures where required. Additional monitor installed near a receivers property on Deards Lane, Craven, to provide further data on noise emissions. Daily predicted noise and dust forecast reports are generated and are issued to the mining supervisors prior to each shift.








Site Water Management	Annual water balance review.	 The 2020 annual site water balanced has been prepared. A summary is included in the Annual Review 2020/21 and will be available on the Stratford Coal website.
Water management Structures	Stratford East clean water diversion drain	• The Stratford East Stage 2 clean water diversion has continued and will progress to the south prior to clearing activities being undertaken.
Surface Water Monitoring	Rainfall events	 A major rainfall event occurred on 20 March 2021. Water transfers and monitoring was conducted as required. As a result of the rain event Stratford experience several sediment dam spills and a failure of a culvert on Avondale Creek. Regulatory reporting has been completed as required.
	Routine monitoring	 Routine water sampling continued. All results consistent with the SCM Environmental Assessment predictions. Above average rainfall has been received during summer 2020/21. Multiple high flow rain events occurred during summer 2020/21.
Groundwater Monitoring	Routine monitoring	 Routine groundwater sampling continued. All results consistent with the SCM Environmental Assessment predictions. A recalibration and validation of the Stratford groundwater model is currently being prepared. This will include a revised post-mining groundwater balance and final void water balance. The results will be included in a revision of the Water Management Plan.

Rehabilitated Waste Emplacements	 Avon North waste emplacement Rehabilitation Planning Rehabilitation Maintenance 	 Seeding of the northern side of Avon North waste emplacement was completed in April 2020. Due to poor establishment of vegetation, rework and reseed of the Avon North Waste Emplacement was completed in Q4 2020 Planning phase is complete for rehabilitation works schedule in 2021 which will include progressive backfilling and shaping of the BRN/Avon North waste emplacement and back filling the northern end of Stratford East. The Stratford Main Pit Waste Emplacement Rehabilitation has been slashed during February 2021. This area is not currently stocked. The Codam has also been slashed.
Monitoring	 Vegetation Monitoring - Ecosystem Function Analysis 	 Rehabilitation monitoring incorporating landscape function analysis and vegetation dynamics is scheduled for May 2021. The results will be included in the next Annual Review.






3e. Biodiversity Management

Management Area	Project	Status
Biodiversity Offset Area	Revegetation WorksAnnual Monitoring	 2021 Revegetation planting has been completed. Completed areas include biodiversity offset properties near Craven, Wenham Cox Rd and ex-Foreman/Johnson property. Approximately 14,200 trees over 38 hectares have been planted. Annual vegetation monitoring within the biodiversity offset and enhancement areas was completed in February 2021. A summary of the monitoring is included in the SMC Annual Biodiversity Report and the Annual Review. Both reports are available on the Stratford website.
Weed Control	Weed spraying program	 Weed spraying recommenced in the Stratford Biodiversity Area and Stratford Mining Lease areas in October. Weed spraying has continued through to May 2021 in the Biodiversity Offset area and Mining Lease areas targeting Blackberry, Crofton weed, Tobacco bush, Privet and Lantana.

Nest Box Program	Nest Box Installation	 An additional 93 Nest boxes were installed in the Stratford Biodiversity Area and Biodiversity Enhancement Area in March 2021. These nest boxes are to specifically target the Squirrel glider and other arboreal fauna.
	Nest box Monitoring	 Nest box monitoring was undertaken in February and May 2021. Monitoring in 2020 showed 50% of nest boxes had signs of use 6 months after installation, 5 nest boxes in total were occupied by Squirrel Gliders. Monitoring will continue quarterly for the new boxes in 2021. A summary of the nest box progress is included in the 2020 Annual Review.

Water Management	Site water Balance	 SCPL will review the site water balance and final landform drainage design to ensure comparable drainage density to local natural landforms.
