
- 3. In the definition of "Department", delete "Industry and Environment" and replace with 'Housing and Infrastructure".
- 4. In the definition of "EA":
 - a. delete the "and" at the end of the 15th bullet point;
 - b. delete the full stop at the end of the last bullet point and replace with "; and"; and c. insert:
 - Modification Report CWO Transmission Line, dated 30 August 2024;"
- 5. In the definition of "Resources Regulator", delete "Regional NSW" and replace with "Primary Industries and Regional Development".
- 6. Throughout the consent, replace "BCD" with "BCS", except for Condition 39 and Condition 77(k) of Schedule 3.
- 7. In Condition 39 and Condition 77(k) of Schedule 3, replace "BCD" with "Heritage NSW".
- 8. Throughout the consent, replace "DAWE" with "AG DCCEEW" and replace "DPIE Water" with "Water Group".
- 9. In condition 6 of Schedule 2, insert the following note:

"Notes:

- The above limits should be read in conjunction with the extraction limits in Project Approval 08_0135 for the Moolarben Coal Project Stage 2.
- The total ROM coal extracted from the Moolarben mine complex (open-cut) is no more than 16 million tonnes in any calendar year.
- The total ROM coal extracted from the Moolarben mine complex (underground mining) is no more than 8 million tonnes in any calendar year.
- The total ROM coal extracted from the Moolarben mine complex (open-cut and underground mining) is no more than 24 million tonnes in any calendar year."

10. Delete conditions 7b and 7c of Schedule 2.

- 11. In condition 33b of Schedule 3:
 - a. delete the full stop after subparagraph (iv) and insert "; and"; and
 - add "(v) a protocol that has been prepared in consultation with the owners of the CWO REZ Transmission Project to review opportunities of increased water sharing between these projects."
- 12. In Table 12 within condition 34 of Schedule 3:
 - a. in the rows corresponding to *Areas 1, 2, 3, Properties 6, 10, 12 13, 14 and 15*, replace "1282" with "1272", "48" with "44" and "1330" with "1301";
 - b. in the rows corresponding to *Area 1 Properties 12, 13, 14 and 15*, replace "153" with "138"; and
 - c. in the rows corresponding to *Properties 24 and 25*, replace "59" with "49" and "4" with 3".
- 13. In condition 65 of Schedule 3:
 - a. delete the first sentence and replace with "The Proponent must rehabilitate the site in accordance with the conditions imposed on the mining lease(s) associated with the development under the *Mining Act 1992*."; and
 - b. after Table 13, add:
 "Note: The Proponent must prepare and implement a Rehabilitation Management Plan in accordance with the conditions imposed on the mining lease(s) associated with the development under the Mining Act 1992."
- 14. Delete condition 68 of Schedule 3.







Figure 2.2 – Location of Surface Infrastructure associated with MOD 16
